# BICYCLE AND PEDESTRIAN ADVISORY COMMISSION REQUESTS, INFORMATION ITEMS, AND SUBCOMMITTEE REPORTS

### (E) <u>INTRODUCTION OF STAFF</u>

Mr. HREN introduced Stephanie Dietz, Interim City Manager, Venus Rodriguez, Finance Officer, and Jessie Lee, Temporary Development Services Technician I. Each member of staff briefly spoke to the Commission regarding their roles in supporting the Commission and the City.

### (F) FEEDBACK ON SHARROWS

Mr. HREN introduced the item and asked for Commissioners' opinions of the epoxy sharrows. Mr. BELTRAN explained that the majority of sharrows currently installed in Merced are thermoplastic rather than epoxy. The Commission discussed signage and education to support users of all modes understanding the meaning and appropriate actions to take when sharrows are present. Mr. BELTRAN described the planned transition between bike lanes and sharrows on M Street.

# (G) ATP PROJECT LIST

Mr. HREN introduced the item, expressing staff's interest in hearing any modifications the Commission would like to see to the Bicycle and Pedestrian Tables of the Active Transportation and Safe-Routes-to-School Plan. The Commission expressed that project PS9 appeared to be complete, project BS4 should be removed from the document and added to a regular maintenance schedule, and that projects PS16 and PS15 require modifications to reflect the correct improvements needed.
