The Public Works Sewer crew continued with mowing and discing for weed control this week.



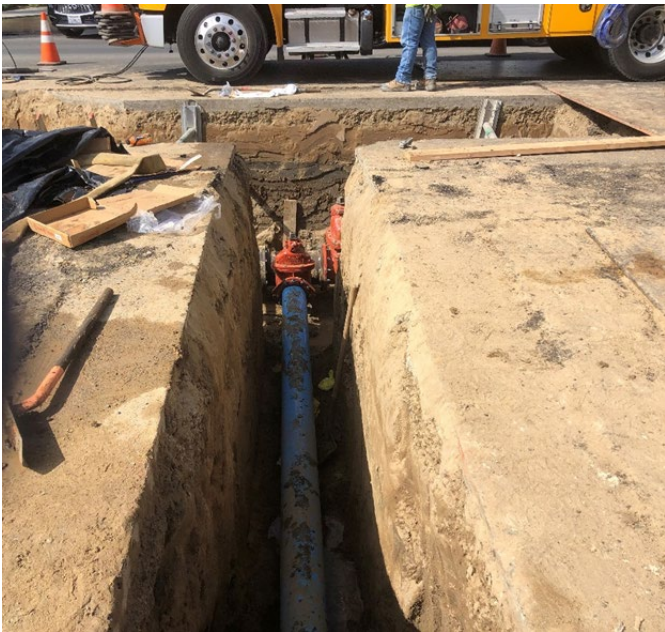
NEW PLAYGROUND FIBER AT RAHILLY PARK

On Thursday, the Public Works Water crew performed repairs at the intersection of Orchard Lane and 18th Street.



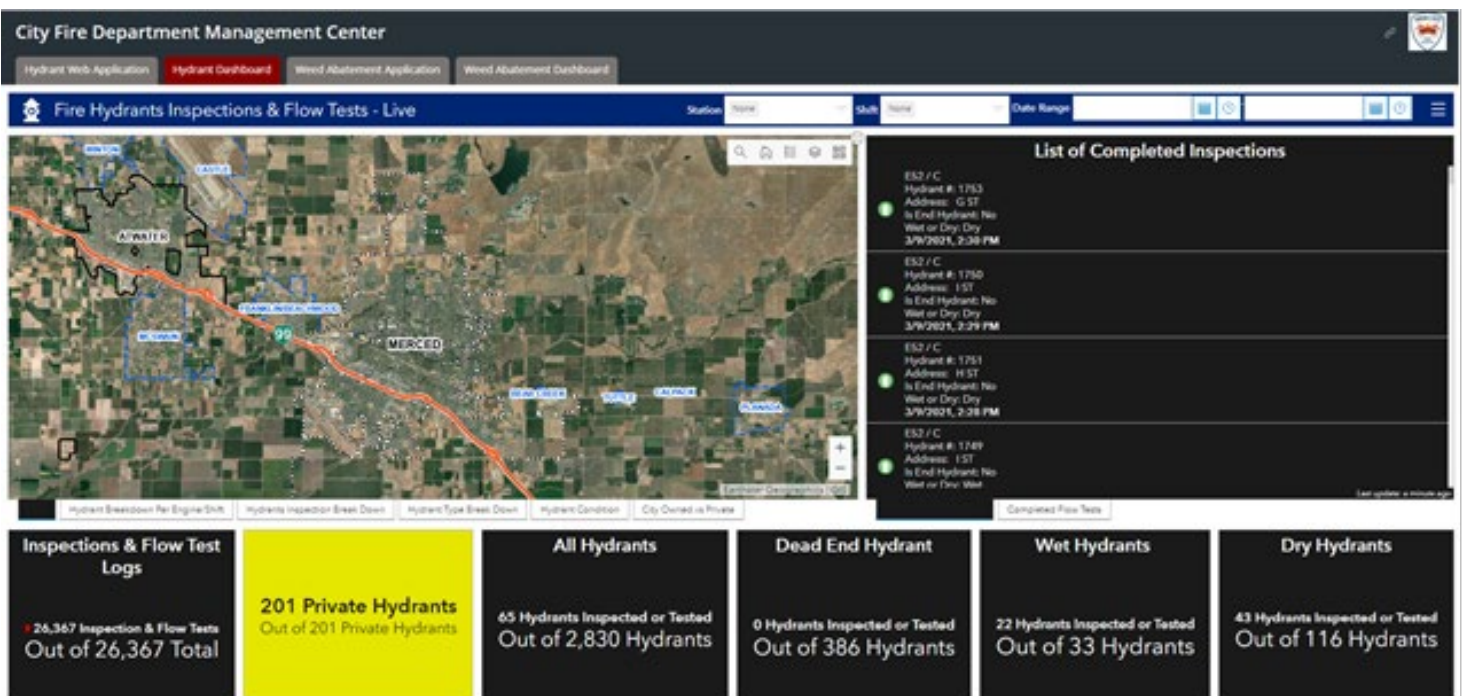
TESLA CHARGING STATION NOW IN MERCED

TESLA installed 12 EV charging units at the University Plaza in front of Smart & Final located near Martin Luther King, Jr. Way and Highway 99. Commuters can exit Highway 99, plug in the charger into that vehicle, shop or grab a bite to eat while their vehicle is charging. Superchargers can add up to 200 miles of range in just 15 minutes.



MERCED FIRE DEPT. BEGINS BIANNUAL TESTING

The Merced Fire Department began their spring testing of fire hydrants. Hydrant testing is done twice a year for nearly 3,000 hydrants within city limits. Testing is crucial to the department’s mission to ensure there are working hydrants with adequate water supply for firefighting capabilities. The Fire Department worked with their internal partners at the Water Division to guarantee the water system is being flushed properly. MFD also worked with the GIS Coordinator to track and report deficiencies with hydrants to streamline processes and expedite repairs. MFD has leveraged their social media platforms to inform the community of the hydrant testing and make them aware of the hazards of driving through a hydrant flowing water.



MFD TRAINING WEEK OF 3/8/21 - 3/11/21

Over the last four days, members of the Merced Fire Department and Merced County Environmental Health trained to the HAZMAT Technician level and participated in a hazardous materials identification course known as HazCat. The course is designed to give the HAZMAT Technician a working knowledge of basic field identification of chemicals found across multiple industries as well as those unknown chemicals dumped along the roadway, dropped off in an alley, or involved in some type of accident. The class provides the technicians the necessary skills to make safe, informed decisions, and comply with federal law regarding proper identification of unknown materials. Through a series of short lectures followed by extended hands-on laboratory time and review, trainees learned to field detect and identify solids, liquids, organic, and inorganic chemical mixtures.

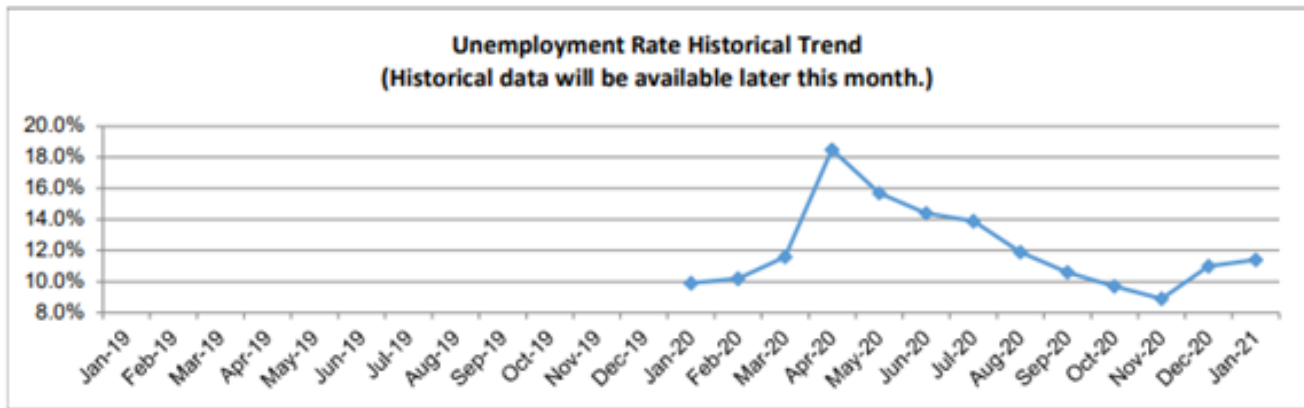

LABOR MARKET REPORT JANUARY 2021

The unemployment rate in the Merced County was 11.4% in January 2021, up from a revised 11.0% in December 2020, and above the year-ago estimate of 9.9%. This compares with an unadjusted unemployment rate of 9.2% for California and 6.8% for the nation during the same period. For the period of February 8th, 2021 through March 7th, 2021, there were 58 New Single Family Dwelling Permits Issued.

The running total of New Single Family Dwellings in Plan Review is **324**.

Multi Family Permits in review:

Gateway Terrace Apartments located at 405 W 12th St; 1 office/lounge and 6, 2 story apartments: 2 buildings have 16 units, 3 buildings have 30 units, and 1 building has 4 units for a total of 126 units.

Compass Pointe phase II: 128 units in 16, 8-plex buildings, plus a clubhouse.

There were 5 CofOs issued for this period; one for Walmart's online grocery pick up located at 3055 Loughborough Dr., one for a shell building located at 2933 G St., one for a 1,935 SF Starbucks located at 1665 R St., one for a 7,200 SF aircraft hangar located at 15 Condor Way, and one for a 7,500 SF storage building and warehouse located at 2250 Cessna Way.

SUMMARY

This is a request to amend the General Plan Designation from Commercial Office (CO) and Industrial (IND) to Business Park (B-P) for a 3.38-acre site located at the northeast corner of State Highway 59 and Olive Avenue. Additionally, the request includes Site Utilization Plan (SUP) Revision #1 to Planned Development (P-D) #12 to allow for a proposed mini-mart with fuel island, a proposed drive-through business, and a proposed office/retail building. Staff is recommending approval of the request with conditions.

RECOMMENDATION

Planning Staff recommends that the Planning Commission recommend approval to the City Council of Environmental Review #20-36 (*Mitigated Negative Declaration*), General Plan Amendment #20-02, and Site Utilization Plan Revision #1 to Planned Development #12 (including the adoption of the Draft Resolution at Attachment A) subject to the conditions in Exhibit A and the findings/considerations in Exhibit B, and the Mitigation Monitoring Program in Exhibit C of the Draft Resolution.

SUBJECT: Zoning Ordinance Amendment #21-01, initiated by the City of Merced. This application involves changes to the Merced Zoning Ordinance (Title 20 of the Merced Municipal Code) which would amend Merced Municipal Code Sections 20.74 (Appeals), 20.44.170 (Commercial Cannabis Businesses), 20.64 (Administrative Responsibility), 20.68 (Permit Requirements), and 20.70 (Public Notice and Hearings). This amendment would clarify that appeals of actions by the Planning Commission, Site Plan Review Committee, and the Director of Development Services would be scheduled for a public hearing by the appropriate review authority and heard within 90 days unless otherwise mutually agreed to by the applicant and appellant; and modify the appeal procedures for Commercial Cannabis Business Permits to match the same language (the current requirement is 30 days). This amendment would also clarify that any action of the Planning Commission requires a vote of at least four members of the Planning Commission for all actions listed in Table 20.64-1 (Review and Decision-Making Authority), including Conditional Use Permits and other permits, approvals, and recommendations. *****PUBLIC HEARING****

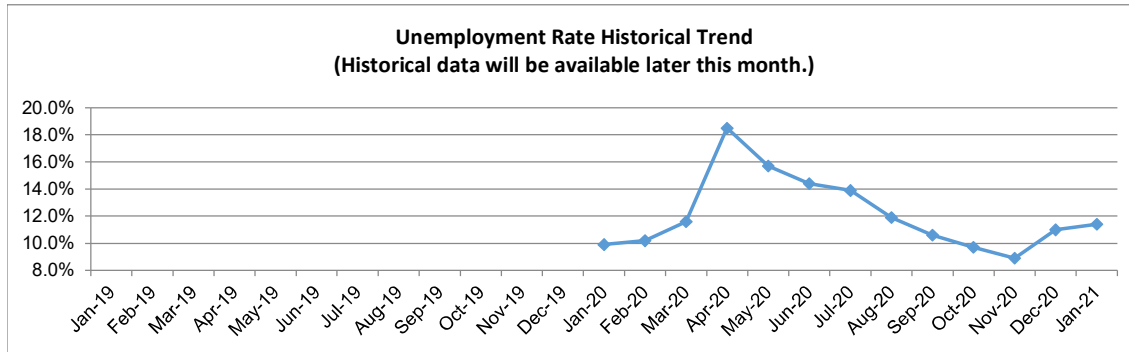
