***DESCRIPTION***

The viability of neighborhoods is extremely important in maintaining and improving the quality of life for our citizens. The neighborhood environment in terms of physical attractiveness and safety is the most critical element that citizens use in evaluating livability in their community. All of Merced's neighborhoods should be places where people feel safe and take pride. In order to achieve these conditions throughout the community, additional Code Enforcement resources were made available in the FY 1999-2000 budget. The program continues, with Code Enforcement Specialists working in concert with neighborhood residents, the Police Department, and other City departments.

The Code Enforcement Program strives to revitalize and maintain the viability of neighborhoods through cooperation and collaboration with citizens, state, county and other City Departments.

## ***2004-2005 BUDGET HIGHLIGHTS***

A major source of funding support for the Code Enforcement Program is Community Development Block Grant funds. General Funds also contributes part of the program total. Three Code Enforcement Specialist positions are currently in the budget.
