Thank you Stephanie for your email.

It is my understanding that my attorney is in court the majority of today. I want to also clarify that after much consideration the only 2 options that may work for us are option 1 and 4, with 4 being abandonment subject to a right of way agreement that provides the general public a 4 foot wide unobstructed right of way for public travel from Main Street to the alley and vice versa during normal business hours 7:30AM until 5:30PM. Option 4 is the 2nd best chance we have to eliminate the criminal element that has plagued our property and tenants for so many years, while providing a clean inviting walkway for the general public during normal business hours. As mentioned to you we have gone from 3-5 calls a week for police intervention to no crime at all in 6 months since our gates have gone up and our construction started.

The general problem with "Easements" is they can never be legally completely blocked/fenced off. Keeping any sort of "Easement" over our property would quickly bring back the vagrancy, arson, burgaries and other public nuisance and crime, as it would legally be required to remain open 24 hours a day, 7 days a week.

As a stakeholder and developer here in Downtown Merced, I would hope that the City will work with us in this regard as an honest compromise if option full abandonment is not provided. Perhaps the City should consider a policy to eliminate all narrow "Easements" in the downtown core in favor of "right of way" agreements that are only open during normal business hours so that the downtown has a Greater chance to reduce crime and create a safer, cleaner and more prosperous downtown.

With right of way agreements, a public path of travel can remain open during normal business hours when the owners of the properties and businesses there can supervise the situation and take immediate action to curtail, correct and or report any vagrancy and or crime.

Easements are more appropriate for landlocked properties where the "Easement" is the only path of travel thus making them necessary.

Although we would object to the City not providing us at our property the same opportunity that the City of Merced has provided The El Capitan Hotel with their walkway, should the

City of Merced now insist that our walkway somehow remain open to the general public, we welcome the City participation in option 4 with the City removing the planter boxes, providing gates/with magnetic locks and paving over the walkway/ providing drainage and A.D.A. compliance in a delineated 4 foot path of travel with perhaps yellow lines on the ground to signify the unobstructed path of travel. The City could take liability for any and all incidents happening in the path of travel while we would take liability for any incidents happening after 5:30PM and until the gates unlock again at 7:30AM Monday through Friday.

I welcome any feedback that you or the City Attorney has in this regard.
