### **ATTENTION CITY OF MERCED UTILITY CUSTOMERS**

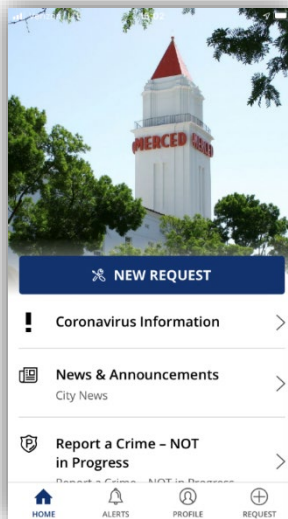
After the water shut off moratorium ended December 31, 2021, Merced City Council elected to continue to defer water shut offs and late fees for customers with delinquent utility bills. At the February 22, 2022 Council Meeting, City Council provided guidance that the utility delinquency and shut off policy would be reinstated as of July 1, 2022. 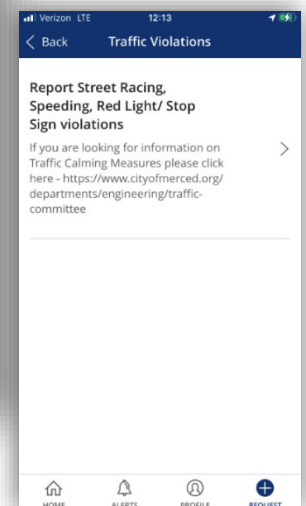
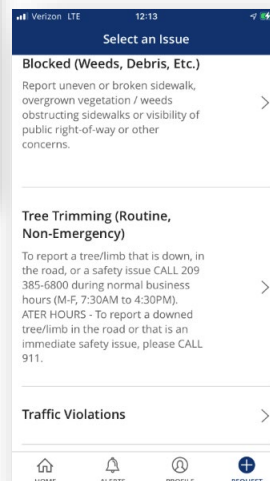
