

ORDINANCE NO. 2542

**AN ORDINANCE OF THE CITY COUNCIL OF
THE CITY OF MERCED, CALIFORNIA,
AMENDING SECTIONS 10.16.010, “SPEED
LIMITS,” 10.28.230 “NO PARKING ZONES,”
10.28.235, “MOTORCYCLE PARKING,” 10.28.275,
“DISABLED PERSONS – ON-STREET PARKING,”
10.28.350, “TEN-MINUTE PARKING ZONES,”
AND 10.32.056, “PASSENGER LOADING ZONES –
PERMANENT” OF THE MERCED MUNICIPAL
CODE**

**THE CITY COUNCIL OF THE CITY OF MERCED DOES ORDAIN
AS FOLLOWS:**

SECTION 1. AMENDMENT TO CODE. Section 10.16.010, “Speed Limits,” of the Merced Municipal Code is hereby amended by deleting the following speed limit:

“Street:
Donna Drive

Portion:
Thirty-five (35) miles per hour
between R Street to M Street”

SECTION 2. AMENDMENT TO CODE. Section 10.16.010, “Speed Limits,” of the Merced Municipal Code is hereby amended by adding the following speed limit:

“Street:
Donna Drive

Portion:
Thirty (30) miles per hour
between R Street to M Street”

SECTION 3. AMENDMENT TO CODE. Section 10.28.230, “No Parking Zones,” of the Merced Municipal Code is hereby amended by adding the following portions of the following streets:

“Street:
South Side of Buena Vista
Drive

Portion:
Beginning at the west line of San
Mateo Court, thence westerly 20
feet

South Side of Buena Vista Drive	Beginning at the east line of San Mateo Court, thence easterly 20 feet
South Side of Buena Vista Drive	Beginning at the west line of San Ramon Court, thence westerly 20 feet
South Side of Buena Vista Drive	Beginning at the east line of San Ramon Court, thence easterly 20 feet
South Side of Buena Vista Drive	Beginning at the west line of San Felipe Court, thence westerly 20 feet
South Side of Buena Vista Drive	Beginning at the east line of San Felipe Court, thence easterly 20 feet
South Side of Buena Vista Drive	Beginning at the west line of San Jacinto Court, thence westerly 20 feet
South Side of Buena Vista Drive	Beginning at the east line of San Jacinto Court, thence easterly 20 feet
South Side of Buena Vista Drive	Beginning at the west line of San Luis Rey Court, thence westerly 20 feet
South Side of Buena Vista Drive	Beginning at the east line of San Luis Rey Court, thence easterly 20 feet
South Side of Buena Vista Drive	Beginning at the west line of San Rafael Court, thence westerly 20 feet

South Side of Buena Vista Drive	Beginning at the east line of San Rafael Court, thence easterly 20 feet
East side of K Street	Beginning 103 feet north of the north line of 18 th Street, thence northerly 103 feet
North side of Cooper Avenue	Beginning at the southwest corner of 2651 Cooper Avenue beginning 30 feet west of the western return of the driveway entrance, thence westerly to 30 feet beyond the eastern return of the driveway
South side of Grogan Avenue	Beginning at a point that is 243 feet from the west line of West Avenue, thence westerly 140 feet
West side of V Street	Beginning at the north line of West Main Street, thence northerly 165 feet.”

SECTION 4. AMENDMENT TO CODE. Section 10.28.230, “No Parking Zones,” of the Merced Municipal Code is hereby amended by deleting the following portions of the following street:

<i>“Street:</i>	<i>Portion:</i>
North side of Eagle Street	Beginning at a point that is 370 feet from the west line of West Avenue, thence westerly 60 feet
Both sides of Eagle Street	Beginning at the east line of Condor Drive, thence easterly five hundred ten (510) feet.”

SECTION 5. AMENDMENT TO CODE. Section 10.28.235, “Motorcycle Parking,” of the Merced Municipal Code is hereby amended by adding the following portions of the following street:

<i>“Street:</i> East side of N Street	<i>Portion:</i> Beginning at 138 feet north of the north line of 16 th Street, thence northerly 7 feet
East side of N Street	Beginning at 127 feet south of the south line of 18 th Street, thence southerly 12 feet
West side of N Street	Beginning at 142 feet south of the south line of 18 th Street, thence southerly 7 feet
West side of N Street	Beginning at 212 feet south of the south line of 18 th Street, thence southerly 14 feet”

SECTION 6. AMENDMENT TO CODE. Section 10.28.275, “Disabled Persons – On-Street Parking,” of the Merced Municipal Code is hereby amended by adding the following portions of the following street:

<i>“Street:</i> East side of N Street	<i>Portion:</i> Beginning at 43 feet south of the south line of 18 th Street, thence southerly 46 feet
East side of N Street	Beginning at 49 feet north of the north line of 16 th Street, thence northerly 33 feet”

SECTION 7. AMENDMENT TO CODE. Section 10.28.350, “Ten-Minute Parking Zones”, of the Merced Municipal Code is hereby amended by adding the following portions of the following street:

<i>“Street:</i>	<i>Portion:</i>
North Side of Buena Vista Drive	Beginning at 75 feet east of the east line of San Lorenzo Way, thence easterly 50 feet”

SECTION 8. AMENDMENT TO CODE. Section 10.32.056, “Passenger Loading Zones – Permanent,” of the Merced Municipal Code is hereby amended by adding the following portions of the following street:

<i>“Street:</i>	<i>Portion:</i>
West Side of N Street	Beginning at 41 feet north of the north line of Main Street, thence northerly 42 feet”

SECTION 9. EFFECTIVE DATE. This Ordinance shall be in full force and effect thirty (30) days after its adoption.

SECTION 10. SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 11. PUBLICATION. The City Clerk is directed to cause a summary of this Ordinance to be published in the official newspaper at least once within fifteen (15) days after its adoption showing the vote thereon.



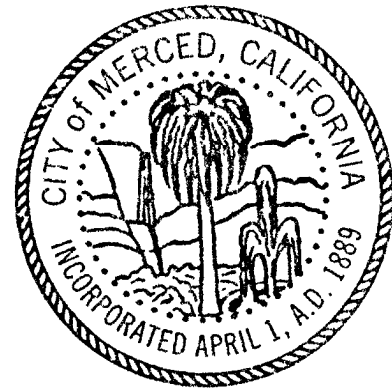


