DOMESTIC VIOLENCE UPDATE

COURSE GOAL

This course will provide in-service patrol officers with training that meets the requirements of PC 13519(g). Students will receive instruction on legal updates including strangulation, stalking, protection orders, and gun violence restraining orders. They will learn about the cycle of violence and the impact on the family, as well as the importance and availability of community resources to foster and cultivate trust with victims.

EXPANDED COURSE OUTLINE

I. CYCLE OF VIOLENCE AND IMPACT ON THE FAMILY

- A. Behaviors Batterers Use to Instill Fear and Control Over Their Partner
 - 1. In groups, officers will discuss “What do peace officers encounter on calls for service (DV)?
 - 2. Purpose these behaviors serve – the end goal
- B. Victim Characteristics and Behaviors
 - 1. National Domestic Violence Hotline Study
 - 2. PTSD vs Battered Women’s Syndrome
- C. Impacts on a Child at Time of Law Enforcement Intervention
 - 1. Still Face baby video (the good, the bad, the ugly)
 - 2. Review study of childhood neglect and brain development

1. Check the box for immediate surrender
 2. Anticipatory warrant or Georgia vs Randolph
 3. Applicable citations
- D. Explaining Conditions Met to Judge/Commissioner
1. Immediate and present danger to self or others (PC 18155, PC 18150(b)(1), PC 18150(b)(2))
 2. 21-day order unless extension authorized
 3. Firearm use is NOT required

V. LEARNING ACTIVITES

- A. Learning Activity 2
1. Students will collaborate in small groups to identify legal mandates all peace officers shall abide by. Groups will complete the following tasks:
 - a. Identify legal mandates that “shall” be done per Penal Code
 - b. Identify legal mandates that “shall” be done per Family Code
 - c. Identify legal mandates outlined in the Government Code
 - d. Determine what actions are found in the POST Guidelines for Domestic Violence as factors that shall NOT be considered
 - e. Determine actions that are beneficial but not required
