Preliminary Public Service Projects and Budget*

What is a public service program? Public service programs can strengthen communities by addressing the needs of specific populations, including homeless, elderly, or youth individuals and low-income households. Public services are an integral part of a comprehensive community development strategy, and can address a range of individual needs of residents and increase the positive impact of CDBG dollars by complementing other activities or by filling service gaps that other programs or funding sources are not able to provide. Services provided can include those centered around case management, job training, substance abuse or mental health counseling, homelessness prevention, transportation, and health care, and are systems and solutions that can benefit various groups of individuals. While the City does not have the staffing resources to offer these programs itself, the City relies on the expertise and willingness of local non-profit organizations to provide these vital services to community members through reimbursement with CDBG funds of certain eligible costs.

* The City can only provide up to a total of \$184,685 to public services programs during the 2024 program year. This cap is calculated by first adding the expected 2024 CDBG allocation of \$1,056,567 to the unallocated prior-year CDBG funds that were received as income during the 2023-24 year (\$174,670), then multiplying this total by 15% (\$1,056,567 + \$174,670 = \$1,231,237 x 0.15 = \$184,685). The City received requests for public service project funding totalling \$367,817. At the June 3, 2024, Council meeting, councilmembers were requested to provide direction to City staff as to how they wished staff to prioritize projects, while considering the needs of the low- to moderate-income (LMI) community. The amounts in the right-hand column below reflect that direction. Staff encourages residents and interested stakeholders to provide their own recommendations and suggestions.
