

NOTICE OF PUBLIC HEARING
FOR CONDITIONAL USE PERMIT #1282
AND NOTICE OF INTENT TO ADOPT A CATEGORICAL EXEMPTION

A public hearing will be held by the Merced Planning Commission on Wednesday, October 23, 2024, at 6:00 p.m., or as soon thereafter as may be heard in the Council Chambers of City Hall, 678 W. 18th Street, Merced, CA, concerning Conditional Use Permit #1282, initiated by Maria Aguilar. This application involves a request to operate a food truck in a Central Commercial zone, (C-C), at 301 West 16th Street. The subject site is generally located at the northwest corner of Martin Luther King Jr Way and West 16th Street. The subject site has a General Plan designation of Regional Commercial (RC) and a zoning classification of Central Commercial. Said property being more particularly described as Parcels 16 and the eastern portion of Parcel 15, of Block 187, as shown on that certain map entitled "Supplemental Map to Town of Merced" recorded in Volume 2, Page 12 of Merced County Records; also known as Assessor's Parcel Number (APN) 031-152-11.



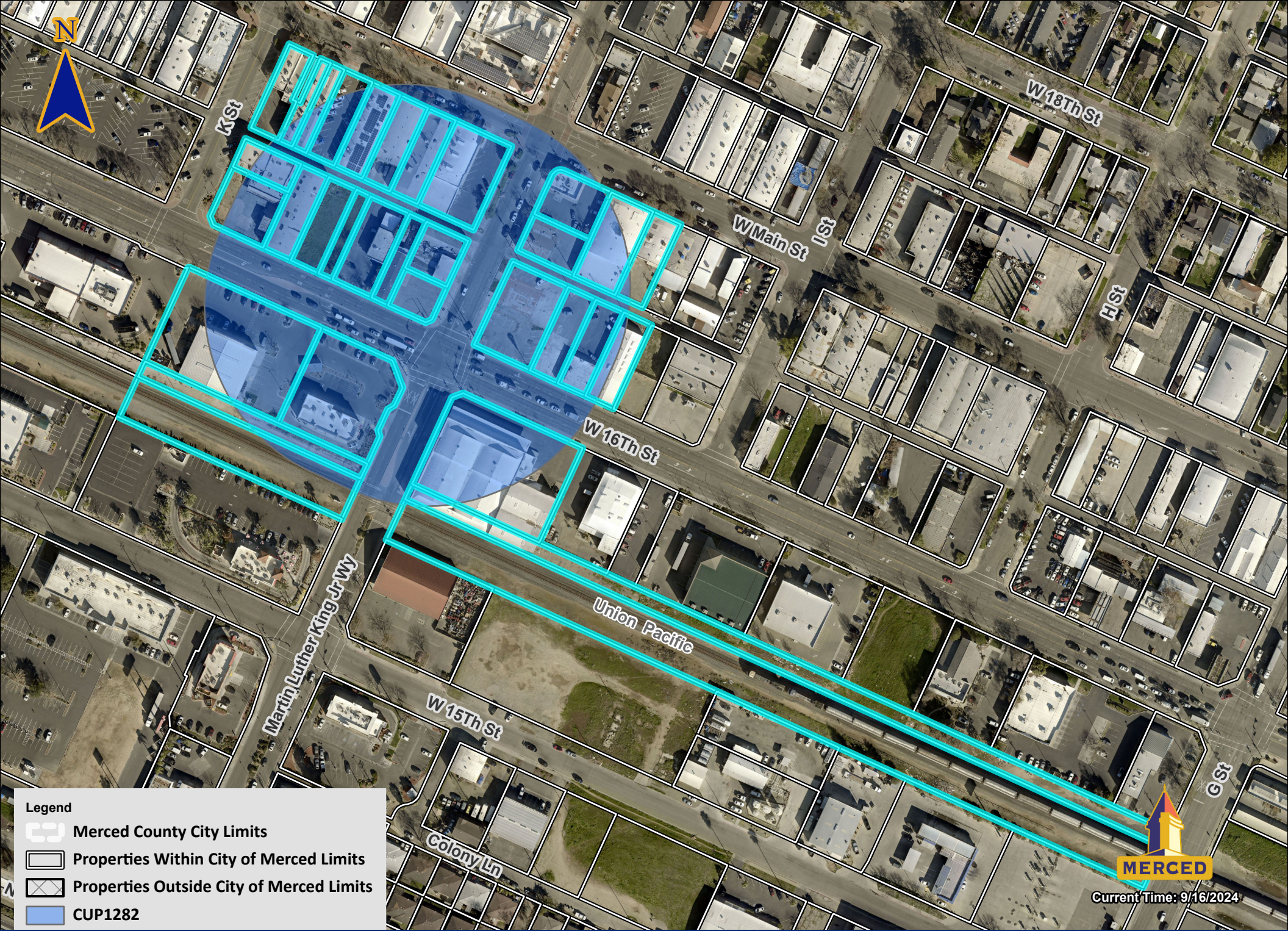

The public review period for the environmental determination begins on October 3, 2024, and ends on October 23, 2024. Please call the Planning Department at (209) 385-6858 for additional information. If you challenge the action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City of Merced at, or prior to, the public hearing.

You may submit your public comment to the Planning Commission electronically no later than 1:00 PM on the day of the meeting. Comments received before the deadline will become part of the record. Material may be emailed to planningweb@cityofmerced.org and should be limited to 300 words or less. Please specify which portion of the agenda you are commenting on, i.e., item # or Public Comment. Your comments will be provided to the Planning Commission at the appropriate time. Any correspondence received before, during, or after the meeting will be distributed to the Planning Commission and retained for the official record.
