BACKGROUND

At the November 13, 2018 meeting of the Traffic Committee, Request #18-013 was heard to readdress painting of red curb on Kelly Avenue between Baker Drive and Highway 140. This request was proposed to limit parking on Kelly Avenue in order to allow enough lane space for traffic travelling in both directions. At this meeting, it was discussed that Kelly Avenue appears to have bicycle lanes painted; however, those lanes are not marked with signs, painted bicycle symbols, or other markers. It was recommended that the situation be brought to the attention of the Bicycle Advisory Commission.

DISCUSSION

Upon further review, it has been concluded that a bike lane on Kelly Avenue north of Highway 140 is not indicated in City of Merced plans. It is believed that the paint was added as a part of a CalTrans project that took place on Highway 140. The Bicycle Advisory Committee is asked to consider whether the lanes on Kelly Avenue serve a valuable cycling purpose; whether there is known ridership using or needing to use this location; and whether there would be preference for adding additional signage to the area, removing the bike lanes, or some other option.

<u>ACTION</u>

Provide a recommendation that Planning staff can take back to the Traffic Committee regarding the bike lanes on Kelly Avenue north of Highway 140.
